Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, intimation is given as under pertaining to litigation against the Company and its subsidiary, Niche Generics Limited, UK:

1. Brief details of the litigation	<ul style="list-style-type: none">• The Servier group, whose parent company, Servier SAS, a French company developed Perindropil, a medicine used in the treatment of hypertension and heart failure; obtained a patent in 2004.• Following disputes in which the validity of the patent was challenged, Servier entered into various settlement agreements with a number of generic companies including Unichem Laboratories Limited and Niche Generics Limited (Wholly Owned Subsidiary of Unichem). On 9 July 2014, the European Commission adopted a decision in which it found that the contested agreements constituted restrictions on competition and also held that the agreements enabled Servier to implement an exclusionary strategy and that Niche and Unichem had acted in breach of EU competition law. The Commission imposed a fine of Euro 13.96 million. <p>This was intimated to the Exchanges on July 10, 2014.</p>
2. Name of the Opposing Party and where the litigation is filed	Niche and Unichem appealed the decision of the European Commission before the General Court of the European Union on 22 September 2014
3. Expected financial implications if any due to compensation, penalty etc	General Court of the European Union has on December 12, 2018 rejected the appeals and has issued a Press Release on its judgment in the matter, and has confirmed the fine of Euro 13.96 million.
